 - Membership Subscriptions payable for the initial year of Membership must be paid in accordance with the By-laws; and

- A Joining Fee of \$3500 will be payable upon application (By-law 5.4)

Applicants who wish to apply for Equity Membership with Family Status

Applicants who are granted Equity Membership with Family Status in accordance with the Club's By-laws will be entitled to a rebate on Annual Membership Subscriptions (as detailed in the Club's By-laws).

Eligibility

Two individual Applicants may apply for Equity Membership with Family Status. The two Applicants must be married to each other or be in a de facto relationship of not less than two years' duration.

Children (up to six in number) forming part of the "Family" may also be entitled to user rights in accordance with the Club's Constitution and By-laws if they are living with the two Applicants (or the one Applicant applying for two or more Convertible Notes), are unmarried and are either:

- a) under the age of 21 years; or
- b) under the age of 25 years who are studying full time at an institution of higher education.
